Can't do anything until we have the real estate attorney to advise the school and receive proper documentation on advisement. The step being proposed is the beginning and will allow us to move forward. We need someone who has done this, successfully. Each charter school is different and requires it's own unique approach to fulfill their program and charter. There are multiple divisions and requirements that take a lot of time to be sure it is done correctly. This is where we start. Malpractice insurance is carried by the real estate attorney at a level that is acceptable and above the \$100,000 requested by the board. Mr. Fuentes has worked with Mr. Dupont's attorney. Attorney's work with attorney's. There is a process that is different from any other process when working with schools. The engagement letter is not a contract.
