Two weeks at Christmas, March shows spring break, last day of school is May 26. If extended learning is eliminated what will be affected? Unknown at this time without knowing if it will happen. Likely it will delay the start of school. More direction will be provided if changes are made by the State. Could they allow it to help make up the time lost due to current pandemic? It is always a possibility but a good idea. We could have done a lot more with our students, however, we had to pull back and follow state guidelines. If this happens again, we will be more prepared and able hopefully provide more. We will see what the State decides moving forward. There is too much that is undecided, currently, to make any decisions.

Notes: Minimum levels will remain the same and reflected in salary schedule. SEG increased by 3.3, 4 increase for raises, 'at risk' increased, 20 decreased small school size adjustment, Medical high option increased 8.7, low option increased by 2.1. SEG decreased.

IDEA B, Lease Assistance 6%, HB33 5%, Perkins Grant is not included as APS has not provided information on amounts, as of yet. Carryover – not included at this time. Instructional Materials (FY21), allocation was provided but not separate funding. The Library Go-Bonds (based on legislature) not included as there is no reward provided at this time.

Expenditures by Function: All budgeted = 78%. This is a positive note. Compared to last year, instruction is increasing. Administration is going up due to building needs for attorney involvement. 59% is for compensation/benefits of employees and staff., (this includes 4% raise), 13.0% contracted services. Personnel Costs: FTE's are the remaining the same. Stipends are included, extended learning. Fund Balance-trends over the past five years. Question: with revenues less and expenditures possibly changing, how will that change things moving forward? The impact, in comparison, would be taken care of in our carry over. Therefore, if extended learning was taken, we should be able to cover it. Without knowing what the state will cut, it is difficult to determine for sure. Our program is very important to us and we have been very fiscally responsible, allowing for us to buffer any decreases in funding. Stacy mentioned how amazing the administration and staff have worked hard to be sure we have a great program and we make decisions that are fiscally responsible. Raj agreed with Stacy. Mr. Tolley thanked his administration and staff for working hard and providing a great program.
