A. School updates

1. Covid

Numbers have started to decline in the last couple of weeks. Reporting is beginning to be less cumbersome but still comprehensive. We have many of our tests and are waiting for more tests to come in.

2. Marketing

Reviewed electronic billboards, Geo-Fencing, and radio station ads for CIS. We should start hearing the advertisements very soon. How are applications going? It is still at a slower pace due to the current circumstances, but we are getting more. More are likely to come in during April and May. Intent to returns is starting to come in as well.

3. Building update and discussion.

There was a possible building near Top Golf, however, would not have worked due to the buildout and pick-up/drop-off needs. Prices in commercial real estate have not dropped off.
